

**SIGHTFULL INSIGHTS LTD. AND SIGHTFULL INC.
WEBSITE TERMS OF USE**

Welcome to <https://sightfull.com/> (together with its subdomains, Content, Marks and services, the “Site”). Please read the following Website Terms of Use carefully before using this Site so that you are aware of your legal rights and obligations with respect to Sightfull Insights Ltd. and Sightfull Inc. (“Sightfull”, “we”, “our” or “us”). By accessing or using the Site, you expressly acknowledge and agree that you are entering a legal agreement with us and have understood and agree to comply with, and be legally bound by these Website Terms of Use, together with our Privacy Policy (“Terms”). You hereby waive any applicable rights to require an original (non-electronic) signature or delivery or retention of non-electronic records, to the extent not prohibited under applicable law. If you do not agree to be bound by these Terms please do not access or use the Site.

1. **Background.** The Site is intended to inform you about Sightfull's products and services.
2. **Modification.** We reserve the right, at our discretion, to change these Terms at any time. Such change will be effective 10 days following posting of the revised Terms on the Site, and your continued use of the Site thereafter means that you accept those changes.
3. **Ability to Accept Terms.** The Site is only intended for individuals aged 13 years or older. If you are under 13 years please do not visit or use the Site. If you are between 13 and 18 years of age, then you must review these Terms with you parent or guardian before visiting or using the Site to make sure that you and your parent or guardian understand these Terms and agree to them.
4. **Site Access.** For such time as these Terms are in force and effect, we hereby grant you permission to visit and use the Site provided that you comply with these Terms and applicable law.

13. **Indemnity.** You agree to defend, indemnify and hold harmless Sightfull and our affiliates, and our respective officers, directors, employees and agents, from and against any and all claims, damages, obligations, losses, liabilities, costs and expenses (including but not limited to attorney’s fees) arising from: (i) your use of, or inability to use, the Site; (ii) your interaction with any Site user; or (iii) your violation of these Terms.

14. **Term and Termination.** These Terms are effective until terminated by Sightfull or you. Sightfull, in its sole discretion, has the right to terminate these Terms and/or your access to the Site, or any part thereof, immediately at any time and with or without cause (including, without any limitation, for a breach of these Terms). Sightfull

shall not be liable to you or any third party for termination of the Site, or any part thereof. If you object to any term or condition of these Terms, or any subsequent modifications thereto, or become dissatisfied with the Site in any way, your only recourse is to immediately discontinue use of the Site. Upon termination of these Terms, you shall cease all use of the Site. This Section 14 and Sections 6 (Intellectual Property Rights), 10 (Privacy), 11 (Warranty Disclaimers), 12 (Limitation of Liability), 13 (Indemnity), and 15 (Independent Contractors) to 18 (General) shall survive termination of these Terms.

15. **Independent Contractors.** You and Sightfull are independent contractors. Nothing in these Terms creates a partnership, joint venture, agency, or employment relationship between you and Sightfull. You must not under any circumstances make, or undertake, any warranties, representations, commitments or obligations on behalf of Sightfull.
16. **Assignment.** These Terms, and any rights and licenses granted hereunder, may not be transferred or assigned by you but may be assigned by Sightfull without restriction or notification to you. Any prohibited assignment shall be null and void.
17. **Governing Law.** These Terms and the relationship between you and Sightfull shall be governed by and construed in accordance with the laws of the State of Israel, without regard to its principles of conflict of laws. You agree to submit to the personal and exclusive jurisdiction of the courts located in Tel Aviv-Jaffa and waive any jurisdictional, venue, or inconvenient forum objections to such courts, provided that Sightfull may seek injunctive relief in any court of competent jurisdiction.
18. **General.** These Terms shall constitute the entire agreement between you and Sightfull concerning the Site. If any provision of these Terms is deemed invalid by a court of competent jurisdiction, the invalidity of such provision shall not affect the validity of the remaining provisions of these Terms, which shall remain in full force and effect. No waiver of any term of these Terms shall be deemed a further or continuing waiver of such term or any other term, and a party's failure to assert any right or provision under these Terms shall not constitute a waiver of such right or provision. YOU AGREE THAT ANY CAUSE OF ACTION THAT YOU MAY HAVE ARISING OUT OF OR RELATED TO THE SITE MUST COMMENCE WITHIN 1 YEAR AFTER THE CAUSE OF ACTION ACCRUES. OTHERWISE, SUCH CAUSE OF ACTION IS PERMANENTLY BARRED.
